

# PNRR SCHOLARSHIPS (DD.MM. 117 and 118 / 2023) (39<sup>th</sup> cycle)

## ➤ **Abroad and Company Requirements**

The PNRR PhD scholarships - DD.MM. 117 and 118 are aimed at activating PhD courses on specific topics and intend to promote interdisciplinarity, membership of international networks and the intersectionality referred to in the PNRR. To this end, all PhD courses involve the involvement of companies in the definition of the training path, through the PhD student carrying out **compulsory study and research periods in the company and abroad**.

Before starting the periods in the company and abroad, the following information must necessarily be entered into the MUR PNRR database:

*The names/business names of the structures*

*The addresses of the registered and operational offices of the companies/institutions*

*The start/end date of the periods in the company/institution in Italy and abroad*

*The deeds of commitment signed by the company/institution in Italy and abroad according to the attached forms (for the periods in the company carried out at co-financing companies referred to in M. D. 117/2023, commitment deeds are not necessary as the companies have already signed a financing agreement which contemplates the period in the company of the PhD students)*

➤ **Information and Advertising Requirements**

The holders of the scholarships must refer to the operating instructions issued by MUR, to facilitate compliance with the provisions on information and publicity contained in the "Guidelines for information and communication actions by the Implementing Bodies". ➤ **Reporting Requirements for carried out activities**

Each PhD student, via the digital platform of the Ministry, and according to the model made available within the [LINEE GUIDA PER LA RENDICONTAZIONE DESTINATE AI SOGGETTI ATTUATORI DEGLI INTERVENTI DEL PNRR ITALIA DI CUI IL MINISTERO DELL'UNIVERSITÀ E DELLA RICERCA È AMMINISTRAZIONE TITOLARE](#) (cap 5.2.1 page 14), must produce a biannual report containing indications of the time commitment (broken down into months in the company, at headquarters, abroad, if applicable) and a summary of the main activities carried out, also declaring that they comply to the principle of “not causing significant damage to the environment”.

On an annual basis, in addition to the above-mentioned documentation, they must prepare a summary report which describes the activities carried out in the reference year.

At the end of the doctoral course, this report must address all the activities carried out in the reference three-year period.
