Collective memories of transit across the Mediterranean

"The only writer of history with the gift of setting alight the sparks of hope in the past, is the one who is convinced of this: that not even the dead will be safe from the enemy, if he is victorious. And this enemy has not ceased to be victorious." (Thesis VI, On the Concept of History, Walter Benjamin)

Memory, Transit, Mediterranean: these are the three words at the heart of the reflection we want to pursue during these days. Looking at the Mediterranean as a space of transit, we want to explore the stories that inhabit it. Which names do these stories bear? What past do they have, and which unaccomplished futures are inscribed in them?

Telling these stories means recognizing them as part of shared experiences, bringing together different shores of the Mediterranean – Tunisia, Italy, Morocco. Across this space, there are stories of movement, arrivals, desire to leave or return, not always voluntary. There are stories suspended: never arrived and never returned. Bodies landing and bearing no name, bodies sought and not found.

How these stories of movement – attempted, denied, diverted, unstopped – can be enacted in the present, saved from the forced oblivion? How these stories can be intertwined together to compose a tapestry of collective memory from below?

During these two days, we want to create a moment of encounter between groups of family members of the disappeared and those who support them, between researchers and legal practitioners, in order to question the present of the European border regime by looking at the past, at those transit histories that are constantly denied, hidden, and at the collective processes of redeeming these. The field of memory appears to us as a battleground where the definition of mobility - of what is legitimate and what is illegitimate -, the mechanisms of inclusion and exclusion, the rhetoric of the "rule of law" in European societies, the historical responsibility of colonialism, the responsibility for the deadly effects of the governance of this mobility. We want to focus on the constitution of forms of collective memory of transit as an expression, from below, of a politics of memory that, by convening and re-signifying the past, produces different imaginaries of human mobility, the idea of citizenship and post-national forms of social organization.

Our focus will be on:

- Mediterranean as a deadly border
- Memories of transit denied on both sides of the sea
- Legal struggles for the right to memory
- Archives and infrastructure of memory
