- that I have read the selection notice, which states that, pursuant to Legislative Decree No. 196/2003 and the European Data Protection Regulation No. 679/2016, the data provided is collected by the University of Parma for the purposes of managing the comparative procedure and is also processed after any possible assignment of the contract, for purposes related to the management of the same relationship, including the fulfillment of the publication obligations under Art. 15 of Legislative Decree No. 33/2013.

For the purposes of evaluation, I attach to this application:

- Curriculum vitae clearly demonstrating the possession of the necessary qualifications (educational credentials and professional experience), prepared in European format¹;

¹ The curriculum vitae, intended for publication in the “Transparent Administration” section of the University of Parma’s website, must not contain any personal data that is not strictly necessary (therefore, it must not include information such as addresses, contact details, emails, phone numbers, or photographs). For the purpose of publication, the CV must not be signed, to avoid identity theft. Since it is attached to the application and forms an integral part of it, its date and authorship will be inferred from the application itself.

- A copy of a valid identity document.

I also attach a sworn statement attesting to the details of any positions held or the holding of roles in private law entities regulated or funded by the public administration, or the carrying out of professional activities at the University of Parma.

This statement is made pursuant to Articles 46 and 47 of Presidential Decree No. 445/2000, with full awareness of the provisions of Article 76 of the same legislative source.
