Subject: extension of the deadline for the 'Scatti di Sport' photographic contest

Having regard to the Statute of the University of Parma and in particular Article 18;

Having regard to the General Regulation of the University of Parma and in particular art. 17 entitled University Sport Committee;

Having regard to Article 1 of Law No 394 of 28 June 1977, which provides for the establishment of University Sports Committees Sport Committees at Universities;

Having regard to the Ministerial Decree of 18 September 1977 issuing the 'Regulations for the operation of the University Sport Committees';

Having noted the appointment by the Director General as his delegate on the Committee for a two-year academic period, i.e. until 31 October 2025, with the function also of Secretary of Mr Riccardo Marini, Head of the University Relations Area, already appointed with DR no. 2048 of 12 November 2021 for the previous two-year period;

Noted that the University is part of the EU GREEN Alliance, approved by the European Commission in Call 2022 (project no. 101089896-EUGREEN-ERASMUS-EDU-2022-EUR-UNIV) and that within the framework of the activities of Work Package 7 'Working Group on Accessibility, Diversity and Inclusion' it is proposed to carry out a Photo Contest;

Having regard to the fact that the Photo Contest 'Shots of Sport' aims at finding visual expressions of Sport, collecting photographs of University Sport in all its forms and that the best photographs will be awarded prizes for a total of €2,000.00, of which the project ERASMUS_EUGREEN_2023_TERRITORY, item COAN CA.C.B.09.01.04.01 has the necessary availability;

Having regard to the latest resolution of the Sports Committee of 09 May 2024, which approved the project and decided to implement the call for photographic contests 'Shots of Sport';

Having regard to Rectoral Decree no. 2537/2024 of 04/11/2024 approving the issue of the call for entries for the photographic contest 'Shots of Sport';

Having acknowledged the need to extend the deadline of the call for entries, scheduled for 28 February 2025, until 14 March 2025;

Having acknowledged the right to make any amendments and/or additions to the deeds, as provided for in Rectoral Decree no. 2537/2024 of 04/11/2024;
