The remaining candidates are evaluated based on the criteria established by the call and recalled in Minutes No.1 of the Selection Committee.

Criterion No.1 assesses the suitability of the candidate's owned undergraduate degree in view of the Master course the candidate applied for. This criterion takes into account also the courses included in the candidate's Bachelor of Science transcript with respect to the topics covered by the Master degree of the University of Parma, as well as the time elapsed since the Bachelor degree conferral. The maximum score for this criterion is 10 points.

Criterion No.2 takes into account the grading obtained by the candidate in the undergraduate degree, according to GPA or CGPA, where available. The maximum score for this criterion is 15 points.

Criterion No.3 assesses the Curriculum Vitae et Studiorum (CV) of the candidates, including their additional qualifications, experiences and activities. The CV is assessed in relation to the candidate's age, and younger candidates are preferred, as stated in the call for application. Maximum score of this criterion is 15 points.
