## THE RECTOR

**HAVING REGARD TO** the Statute of the University of Parma;

**HAVING REGARD TO** Law No. 240 of 30 December 2010, as subsequently amended, entitled “Provisions concerning the organisation of Universities, academic staff and recruitment, as well as delegation to the Government to promote the quality and efficiency of the university system”;

**HAVING REGARD TO** the “Regulation governing the award of research contracts, pursuant to Article 22 of Law No. 240 of 30 December 2010”, issued by Rector’s Decree No. 663/2025, Prot. No. 97025 of 1 April 2025;

**HAVING REGARD TO** Decree-Law No. 45 of 7 April 2025, converted, with amendments, into Law No. 79 of 5 June 2025, and, in particular, Article 1-bis, which amended Law No. 240 of 30 December 2010 by introducing Articles 22-bis and 22-ter;

**HAVING REGARD TO** the resolutions adopted by the Academic Senate No. SA/28-10-2025/137 and by the Board of Administrators No. CDA/30-10-2025/389, at their respective meetings held on 28 and 30 October 2025, by which the “Regulation governing the award of research contracts, postdoctoral appointments and research assignments pursuant to Articles 22, 22-bis and 22-ter of Law No. 240 of 30 December 2010” was approved;

**CONSIDERING**, therefore, the need to proceed with the enactment of the aforementioned Regulation;

## DECREES AS FOLLOWS

1. The “Regulation governing the award of research contracts, postdoctoral appointments and research assignments pursuant to Articles 22, 22-bis and 22-ter of Law No. 240 of 30 December 2010” is hereby enacted in the text annexed to this measure, of which it forms an integral and substantive part.
2. The aforementioned Regulation shall enter into force on the day following the date of its publication on the University’s online official noticeboard.
3. With effect from the date of its entry into force, this Regulation repeals the “Regulation governing the award of fixed-term research contracts pursuant to Article 22 of Law No. 240 of 30 December 2010”, issued by Rector’s Decree No. 663/2025, Prot. No. 97025 of 1 April 2025.
