



PUBLIC NOTICE AIMED AT COLLECTING EXPRESSIONS OF INTEREST FOR THE DIRECT AWARD, PURSUANT TO ART. 22 TER OF LAW NO. 240 OF 30.12.2010 AND THE RELATED UNIVERSITY REGULATIONS, AS PART OF THE CIRCEM PROJECT (CUP D93C22001140001), OF NO. 1 RESEARCH ASSIGNMENT, LASTING 12 MONTHS, ENTITLED "*MONITORING AND QUANTITATIVE ANALYSIS OF INDICATORS OF THE WELFARE CONDITIONS OF NON-HUMAN PRIMATES IN CAPTIVITY IN RELATION TO DIFFERENT TYPES OF ENVIRONMENTAL ENRICHMENT PROGRAMS*", (GSD) 11/PSIC-01 – GENERAL PSYCHOLOGY, NEUROPSYCHOLOGY AND COGNITIVE NEUROSCIENCE, PSYCHOMETRICS, (SSD) PSIC-01/B – NEUROPSYCHOLOGY AND COGNITIVE NEUROSCIENCE, AT THE DEPARTMENT OF MEDICINE AND SURGERY - rectification Art. 6

THE RECTOR

HAVING REGARD to the Statute of the University of Parma;

RECALLED the current "*Regulations for the awarding of research contracts, post-doc appointments and research assignments pursuant to articles 22, 22 bis and 22 ter of Law no. 240 of 30 December 2010*", issued with Rector's Decree no. 1851/2025, prot. 314523 of 7 November 2025, subsequently amended by Rector's Decree no. 533/2026, prot. no. 119125 of 10.04.2026;

RECALLED, also, the "*Regulation on the discipline of research, consultancy, teaching and higher education activities carried out by the University of Parma against contracts or agreements with third parties*", issued with Rector's Decree no. 2298/2024, prot. 264866 of 4.10.2024;

RECALLED its Rep. Decree no. 1100/2026, prot. no. 240505 of 20.07.2026 with which a public notice was launched aimed at collecting expressions of interest for the direct award, pursuant to art. 22 ter of Law no. 240 of 30.12.2010 and the related University Regulations, as part of the CIRCEM Project (CUP D93C22001140001), of no. 1 research assignment, lasting 12 months, entitled "*Monitoring and quantitative analysis of indicators of the welfare conditions of non-human primates in captivity in relation to different types of environmental enrichment programs*", (GSD) 11/PSIC-01–GENERAL PSYCHOLOGY, NEUROPSYCHOLOGY AND COGNITIVE NEUROSCIENCE, PSYCHOMETRICS, (SSD) PSIC-01/B–NEUROPSYCHOLOGY AND COGNITIVE NEUROSCIENCE, at the Department of Medicine and Surgery [Ref. Code 2026idr017];

NOTING that art. 6, entitled "*Approval of acts of the direct assignment procedure*", of the aforementioned notice, contains provisions relating to the duration and scrolling of the ranking, as well as the assignment of further assignments through the use of the same;

HAVING ASCERTAINED that these provisions apply, pursuant to the above-mentioned Regulation, exclusively to public selection procedures for the awarding of research assignments and not also to direct award procedures;

WHEREAS, therefore, it is necessary to provide, by way of self-protection and in order to ensure the compliance of the notice with the regulatory framework in force, the correction of art. 6, eliminating the provisions concerning the validity and scrolling of the ranking list and the conferral of further assignments;

WHEREAS the correction does not affect the requirements for participation, the criteria and methods of evaluation, nor the deadline for the submission of expressions of interest, and does not cause any harm to potential participants;

DECREES



1. to rectify, for the reasons expressed in the preamble as well as an integral part of this measure, the public notice aimed at collecting expressions of interest for the direct award, pursuant to art. 22 ter of Law no. 240 of 30.12.2010 and the related University Regulations, as part of the CIRCEM Project (CUP D93C22001140001), of no. 1 research assignment, lasting 12 months, entitled "*Monitoring and quantitative analysis of indicators of the welfare conditions of non-human primates in captivity in relation to different types of environmental enrichment programs*", (GSD) 11/PSIC-01–GENERAL PSYCHOLOGY, NEUROPSYCHOLOGY AND COGNITIVE NEUROSCIENCE, PSYCHOMETRICS, (SSD) PSIC-01/B–NEUROPSYCHOLOGY AND COGNITIVE NEUROSCIENCE, at the Department of Medicine and Surgery [Ref. Code 2026idr017], limited to art. 6;
2. to replace art. 6 of the notice with the following text:
"ART. 6 – APPROVAL OF THE ACTS OF THE DIRECT ALLOCATION PROCEDURE
The acts of the direct award procedure are approved by Rector's Decree, including the name of the selected candidate and the merit ranking of the unselected eligible candidates, published on the online Register and on the website of the University of Parma, in the section dedicated to the procedure. From the day of publication of the aforementioned decree, the deadline for any appeals begins."
1. to confirm in any other part the text of the original notice, including the deadline for the submission of expressions of interest, set at 05.08.2026;
2. to arrange for the publication of this decree, drawn up in Italian and English, on the online Register and on the website of the University of Parma, in the section dedicated to the procedure.
