having regard to Italian Decree no. 3988 of 23<sup>rd</sup> December 2010 for the emanation of the Regulation for Doctoral Schools and subsequent modifications;

having regard to the Memorandum of Understanding signed between the Region of Emilia Romagna and the University of Parma, referred to in Italian Decree 2045 of 19<sup>th</sup> June 2012, aimed at the definition of educational profiles within the context of higher education for the achievement of the research doctorate qualification within the scope of the apprenticeship contracts of higher education and research;

having regard to Italian Decree no. 3052 of 10<sup>th</sup> October 2013 of the institution and activation of the XXIX cycle of the courses of research doctorate;

#### **DECLARES**

#### **ART. 1 - INSTITUTION**

Public competitions are held at the University of Parma, for qualifications and exams, for admission to the XXIX cycle (year 2014) of the courses of research doctorate, listed below. For each doctorate is indicated the duration, the places for the competition, the scholarships available and the associated venues.



The number of scholarships will increase as a result of funding from public and private actors that sign the commitment before the expiry date of the competition; official communication of this will be given during the admission test.

#### **ART. 2 - ADMISSION REQUIREMENTS**





Those holding a university degree, according to the rules in force before the entry into force of Ministerial Decree 509/1999 (former order), i.e. Master's Degree, can apply to participate in the admission competition, with no age limits or restrictions on citizenship pursuant to Ministerial Decrees 509/1999 and 270/2004) in one of the classes assimilated to the previous ones, within the meaning of the Interministerial Decree of 9<sup>th</sup> July 2009 published in Official Journal no. 233, 7<sup>th</sup> October 2009, or similar academic qualification achieved abroad. To this end, those who are in possession of an academic qualification that has been achieved abroad that has not already been declared equivalent to a university degree will have to make an express request of suitability, for the sole purpose of enrolling on the course of research doctorate, in the application for participation in the competition also attaching the required documents, translated and legalised by the relevant Italian consular or diplomatic representatives abroad, including a declaration of value of the qualification, according to the rules in force for the admission of foreign students onto degree courses in Italian Universities.

Those who are already in possession of a research doctorate qualification may be admitted to attend, upon passing the selection tests, another course of research doctorate not funded by scholarship.

Candidates who will be graduating within and not later than 31<sup>st</sup> December 2013 are admitted with reserve. In this case, the candidate will be required, after having achieved the qualification by 31<sup>st</sup> December 2013, upon penalty of exclusion, to send self-certification, provided with date and signature, with indication of the University that issued the qualification, the date of achievement and the mark, accompanied by a copy of a valid ID document, to the Courses Service and Doctoral School in the following manner: via e-mail to the address <a href="mailto:dottorati@unipr.it">dottorati@unipr.it</a> or via fax to the number: +39 0521-347042.

#### ART. 3 - APPLICATIONS FOR ADMISSION

Applications for participation in the competition, addressed to the Rector of the University of Parma, to be prepared on plain paper according to the attached example must be sent no later than the 12.00 of 15<sup>th</sup> November 2013 exclusively in one of the following ways:

- delivery to Protocol Service and Current Archive Via Università, 12 Parma, open at the following times: Monday - Wednesday - Friday from 09.00 to 13.00; Tuesday - Thursday from 09.00 to 13.00 and from 15.00 to 17.00;
- by post or courier service to the following address: Al Magnifico Rettore Via Università, 12 - 43121 Parma, indicating on the envelope the following words "Domanda di partecipazione al concorso di Dottorato di Ricerca" [Application for participation in the Research Doctorate competition];
- sending through Pec (certified email address) to the following address: protocollo@pec.unipr.it.

The submission of the application by e-mail or fax is not permitted.





Applications that are received beyond the above deadline will not be considered. As such, the postmark date of the receiving postal service shall not be proof of dispatch.

The application for participation in the competition must be accompanied by a curriculum vitae.

The candidate must complete the application by following the example annex (ANNEX A) to the call for applications and must provide:

- a) their general details, their date and place of birth, and address;
- b) an Italian address to be used for the purposes of the competition to which this Administration will direct any communication;
- c) The exact name of the competition with indication of the Thematic Research chosen (if indicated in the course);
- d) personal citizenship;
- e) the degree awarded according to the rules in force before the entry into force of Ministerial Decree 509/1999 (former order), i.e. Master's Degree,(pursuant to Ministerial Decrees 509/1999 or 270/2004) in one of the degree categories assimilated to the previous ones, within the meaning of the Interministerial Decree of 9<sup>th</sup> July 2009 published in Official Journal no. 233, 7<sup>th</sup> October 2009, or the equivalent qualification achieved at a foreign university, with the date and university at which it was achieved or the presumed date of achievement, ensuring submission of the relevant self-certification to the place of competition where possible or subsequently to the Courses Service and Doctoral School.

The candidate must also declare:

- a) a commitment to attending the course of research doctorate on the basis of the recommendations laid down by the Academic Board.
- b) they know any foreign languages;
- c) they have adequate knowledge of the Italian language (only for foreign nationals);
- d) they are not enrolled at any Schools of Specialisation or on a degree or on a Professional Master's Programmes or ATA (Active Training Apprenticeship). Where this is the case, they shall engage to suspend attendance/enrolment on the same. They declare they are enrolled at the Medical Specialisation School with headquarters at the University of Parma (enclosing, in the latter case, a copy of clearance by the School Council to enrol on the specific course of research doctorate);
- e) they are not a doctor of research or hold the research doctorate qualification (in this case, the winner will not be entitled to a scholarship);
- f) they have not benefited from or are currently benefiting from a research doctorate scholarship.

Candidates with disabilities or specific learning difficulties should integrate the application for registration by completing the form A38 or A38/TER which can be downloaded from the website www.unipr.it/modulistica The completed and signed form should be sent via fax to no. 0521/347042 or sent via e-mail to dottorati@unipr.it.





The candidate should ultimately attach to the application a document in which the same expresses their interest, which is purely indicative and as such not binding, for activation of a "higher education and research apprenticeship contract" to be stipulated pursuant to art. 5, Legislative Decree no. 167/2011 and art. 30, Regional Law no. 17/2005 with any companies involved (possibly using the fac-simile in ANNEX B).

Holders of scholarships conferred on the European Community in the framework of EU research networks , as identified by the Academic Senate , on a proposal from the Departments , are allowed on request to a Doctoral School of the University of Parma after evaluation of merit. The Academic Board may provide for a specific test . The application must contain, in addition to the documentation of the scholarship , a research plan to be developed in the PhD program , a curriculum vitae and two letters of recommendation from teachers of official European University , the question is inspected 'approval of the Board of the Graduate School . If the application proves received within 3 months of the start of the educational activity the applicant is admitted to the PhD program activated for the same cycle Its place is as surplus to the posts made in the announcement for the reference cycle and in any case within the limits of sustainable places .

If the application is received after three months from the start of the educational activity the applicant is admitted in the first cycle following the date of acceptance.

In the application, the candidate must also declare and attach qualifications, publications, or other documents which may be assessed for the purposes of definition of the merit ranking.

The Administration does not assume any liability in the event of the distribution of employee communication due to the incorrect address instructions by the candidate or resulting from the failure to notify or late notification of change of the same, or for any lost mail not attributable to negligence by the same Administration.

Candidates will be requested to retrieve, at their own expense and within 2 months after completion of the competition, any documentation qualifications and publications sent to the University of Parma. With elapse of the period indicated, the Administration will not be responsible in any way for any of the above publications and documentation of qualifications.

#### **ART. 4 - ADMISSION EXAM**

A competition for qualifications and possible examination is envisaged for the admission exam. The procedures for comparative evaluation, aimed at assessing the ability and aptitude of the candidate to scientific research consist of, in addition to a valuation of the qualifications, any test chosen by the Academic Board of the course of research doctorate which may be a written test, an oral test or a practical test. The examination may be sat in Italian or English, to be decided by the candidate.





The Adjudication Panel will be appointed in accordance with the regulations of courses for achievement of the research doctorate.

Qualifications will be valued up to a maximum of 60 points. Candidates that acquire a score lower than 20 in the valuation of qualifications may not be considered suitable.

Within 15 days from the date of publication of the competition notice will be posted, on the University web site, evaluation criteria, withing the mining of art. 8 paragraph 2) of Ministerial Decree 45/2013

The Commission attributes to every candidate up to 60 points for the test.

Any test taken is considered passed if the candidate achieves an assessment of at least 40/60.

The dates of the tests are listed in art. 12 of this competition. The same article may contain information relating to every single exam and the possible Research Topics chosen by the candidate.

Foreign candidates must also demonstrate that they possess an adequate knowledge of the Italian language.

To take the tests, applicants must present themselves with a valid photographic document of recognition issued by a Public Administration. Failure to do so will result in exclusion from the tests.

At the end of the exam, the Panel will complete the general merit ranking on the basis of the scores obtained by candidates in the valuation of qualifications and in any individual tests.

#### ART. 5 - ADMISSION TO THE COURSES

Candidates are admitted to the course according to the ranking order, until filling of the number of places available.

Any reserved seats not allocated can be made available to the admission procedures for the places that are not reserved.

The course starts after the period of enrolment.

Where the candidate is offered several places by means of rankings, the same must choose only one course of the course of research doctorate.

Holders of research scholarships that have passed the exam tests for admission on courses of research doctorate are permitted to access the course of research doctorate, without a scholarship, within the limits of the number of places available.

Non-EU nationals that have passed the exams for admission are permitted to access the course of research doctorate within the limits of the number of places available as part of the competition and in any case within the limits of places available.





Candidates successful in the final merit ranking that have expressed an interest with submission of an admission application (possibly using the facsimile ANNEX B), may later be selected in collaboration with possible companies involved and on the basis of the specific skills of each, for the activation of a "higher education and research apprenticeship contract" art. 5, Legislative Decree no. 167/2011 and art. 30, Regional Law no. 17/2005.

A medical major student enrolled at a specialisation school at the University of Parma that has been successful in a competition for admission onto a research doctorate, at the same location, may be entitled to joint attendance during the last year of specialisation school.

The joint attendance must be compatible with the work and the commitment expected by the same school following clearance issued by the School Council.

The Academic Board of the research doctorate may accept an application for reduction following assessment of the research activities already undertaken during the course of the medical specialisation and certified by the specialisation school council with enrolment in the second year of the research doctorate.

In the course of the year of joint attendance, the major student may not receive a scholarship for the research doctorate.

#### **ART. 6 - ENROLMENT**

Candidates that have passed the tests of the competition must present themselves at the Courses Service and Doctoral School - Piazzale S. Francesco, 3 - 43121 Parma within the time limit established by art. 12, for the research doctorate for which winners of the competition have been selected, accompanied by a photocopy of the document of identity and a photocopy of the tax code.

In the case of withdrawal by any winners of the competition, the Administration will contact and summon other suitable candidates according to the order of the ranking. Interested parties must present themselves at the Courses Service and Doctoral School within 5 working days after the afore-mentioned communication, upon penalty of forfeit.

The citizens of non EU countries must submit a photocopy of the request of the study permit or residence permit and must subsequently provide the permit, issued by the Police Headquarters in Parma.

Candidates with equal ranking must submit, for the purposes of admission to the course, self-certification of their economic situation within the meaning of the Decree of the President of the Council of Ministers 9<sup>th</sup> April 2001 published in Official Journal no. 172, 26<sup>th</sup> July 2001.

Any acts and documents drawn up in a foreign language must be translated and legalised by the relevant Italian diplomatic or consular representatives abroad, according to the rules for the admission of foreign students onto degree courses in Italian Universities.





In the event of withdrawal of a person that is entitled at least two months before the start of the course, the candidate placed according to the order of ranking of suitable candidates shall be offered this place, and in any event, within and not after the third month from the beginning of the course.

#### ART. 7 - SCHOLARSHIPS

The amount of the scholarship is 13,638.47 euro per year gross of INPS [National Social Security Institute] contributions pursuant to art. 1 paragraph 1, letter a) of the Law 3<sup>rd</sup> August 1998 no. 315 and subsequent modifications and integrations. Scholarships will be allocated according to the ranking order. In the event of equal merit, the assessment of the economic situation shall take priority, in accordance with the provisions of the Decree of the President of the Council of Ministers of 9<sup>th</sup> April 2001 published in Official Journal of no.172 of 26<sup>th</sup> July 2001. In the case of suspension of the frequency of courses with a duration of more than 30 days, the scholarship for the corresponding period will not be paid. The suspension of the obligations of attendance of the research doctorate, up to a maximum of one year, is permitted in the event of maternity leave, military service, serious and documented disease and particular family situations with interruption of the provision of the relevant scholarship and subsequent recovery upon resumption of regular attendance.

Suspension of the course is also permitted up to a maximum of one year, with interruption of provision of the relevant scholarship with subsequent recovery upon resumption of regular attendance, for enrolment onto a course of Active Training Apprenticeship.

#### ART. 8 - CONTRIBUTION FOR ACCESS AND ATTENDANCE

The amount of contributions for access and attendance of the courses of research doctorate XXIX cycle is set at € 524.00 per year. This amount shall be increased by € 200.00, € 300.00 and € 400.00 for students whose family has an equivalent economic situation (ISEE) that is respectively higher than € 28,000.00 , € 38,000.00 and € 75,000.00.

The amount of the contribution for access and attendance of the courses must be paid in two instalments:

- The first instalment together with the regional tax and virtual stamp tax must be paid at the time of enrolment;
- The second instalment must be paid by the next 30<sup>th</sup> September 2014 and should include, upon indication of the Administration, any bonus determined on the basis of the economic condition of the doctorate. In order to enable the administration to determine this increase the doctoral student is required to submit ISEE self-





certification, calculated on the basis of their economic circumstances of the previous calendar year, by 31<sup>st</sup> July 2014.

Doctoral students that use scholarships drawn from the university budget to supplement the ministerial funds available are entitled to complete exemption.

Doctoral students with a disability not below 66% are entitled to complete exemption.

Doctoral students registered for the first year that are part of a family with other students enrolled on a course of study (degree, master's etc.) of the University of Parma, are entitled to a refund of € 300 on the second instalment. For recognition of the benefit both the doctoral student and the family indicated as enrolled must be in possession of the following requirements:

- They belong to the same family. Membership of the family is determined by inclusion in the same family status;
- They must be enrolled for the academic year 2013/2014 at the University of Parma.
- They must also comply with the payment of taxes and contributions with regard to previous academic years;
- The applicant must possess both of the following economic values for the 2012 tax year

ISPE/ISPEU not exceeding € 34,926.00 ISEE/ISEEU not exceeding € 28,000.00

All doctoral students enrolled on courses must pay the € 16.00 annual virtual stamp.

All doctoral students that do not benefit from the scholarship are required to pay a € 140.00 annual fee as regional tax.

#### ART. 9 - ACHIEVEMENT OF QUALIFICATION

The qualification of Doctor of Research abbreviated with the letters: "Dr. of Res." or "Ph.D.", is achieved upon passing of the final exam. For all aspects relating to the appointment of the selection committee of the final exam and procedures and obligations relating to the Doctoral research thesis, reference should be made to the Course Regulations governing the courses of research doctorate of the University of Parma.

#### ART. 10 - RIGHTS AND DUTIES OF DOCTORAL STUDENTS

1) The doctoral student is required to ensure attendance of the course of research doctorate, on the basis of the guidelines established by the Academic Board. Admission to the courses of research doctorate involves an exclusive and full-time commitment.

It is the duty of the Academic Board to determine any conditions of compatibility with other extra-curricular activities.





- 2) Within the meaning of Law 14<sup>th</sup> January 1999, no. 4, winners of the competition for admission onto the courses of research doctorate at university clinics may be employed, upon application and approval of the structure that is running the research doctorate, in health care activities if it is compatible with the educational goals of the proposal of the Academic Board.
- 3) Public employees admitted onto courses of research doctorate enjoy for the period of normal duration of the course the terms established by collective bargaining or, for employees within the public arena, special leave for study reasons consistent with the needs of the administration, pursuant to article 2 of law 13<sup>th</sup> August 1984, no. 476 and subsequent amendments, with or without allowances and unless there is an explicit act of withdrawal and only those that are enrolled for the first time on a course of research doctorate, regardless of the disciplinary field.

The period of special leave is useful for the purposes of career progression for pensions and retirement planning.

In the case of admission onto courses of research doctorate without a scholarship, or in waiver of this, the person on leave maintains their salary, social security and pension from the public administration at which the working relationship was established.

Public officials that have already achieved the research doctorate qualification, or public officials that have been enrolled on courses of research doctorate for at least one academic year, benefiting from this special leave are not entitled to special leave, with or without allowances.

If the employee does not take advantage of the special leave provided, admission to the course is dependent upon the approval of the Academic Board after verification that the work is compatible with the activities of education and research provided by the course of research doctorate.

- If, after achievement of the research doctorate qualification, the employment relationship or the commitment with any public administration ceases due to a decision by the employee in the subsequent two years, repayment of the amounts paid shall be due, pursuant to article 2 of law 13<sup>th</sup> August 1984 no. 476, as amended by Legislative Decree No. 119 of 18<sup>th</sup> July 2011.
- 4) The simultaneous enrolment on other courses of study is not permitted, with the exception of that provided for Medical Major students.
- 5) Those enrolled on a course of research doctorate that are holders of a place as a researcher or holding a scholarship or research fellowship may terminate the training after waiving the fee for the scholarship for the research doctorate.
- 6) Doctoral students may perform, as an integral part of the training project and after clearance from the Academic Board tutoring activity of students on degree and master's courses. Teaching activities should be relevant to the course of the doctoral student and will be delivered by means of:
- a) the entrusting of supplementary or subsidiary educational tasks however within the maximum limit of forty hours in each academic year up to the third year of the research doctorate;





b) Participation in exam committees;

c) Collaboration with students in research relating to the final tests and to the final degree thesis.

The teaching activities must not in any case compromise the activity of research training.

The didactic activity is of an optional nature and does not represent a financial burden for the University and can only be entrusted to the doctoral student with consent of the same.

7) The simultaneous use of other scholarships is prohibited, except those granted by Italian or foreign institutions useful to integrate, with stays abroad, the activities of training or research of the major student.
