



Rector's Decree n. 1634/2021, prot. n. 235576 dated 20.09.2021

THE UNIVERSITY RECTOR

Considering law n. 241 dated 07.08.1990, containing rules concerning administrative procedures;
considering the President of Council Ministers decree n. 174 dated 07.02.1994, regarding access of citizens belonging to the European Union member states to jobs in the Public Administration;
considering the Presidential Decree n. 487 dated 09.05.1994, containing norms on access to jobs in the public administration and competition procedures;
considering the Presidential Decree n. 445 dated 28.12.2000, containing the consolidation act on legislative and regulatory provisions regarding administrative documents;
considering Legislative Decree n. 165 dated 30.3.2001, containing general rules regarding the system of employment in the public administration and in particular artt. 35 and 36;
considering the decision of the Board of Administration of the University of Parma CDA/29-07-2021/368, approving the recruitment procedure for a fixed-term Technologist, according to art. 24 bis Law n. 240/2010, deliberated by the Board of the department of Engineering and Architecture dated 14.07.2020, for the European Project H2020-MSCA-ITN-2019 "Photonics for Healthcare: multiscale cancer diagnosis and Therapy - PHAST", Grant Agreement n. 860185;
considering its Rep. Decree no. 1478/2021 prot. n. 207904 of 04.08.2021 calling for the public selection for the recruitment of n. 1 technologist pursuant to art. 24bis Law no. 240/2010 with a fixed-term subordinate employment contract, with full-time hourly commitment, lasting 24 months, with remuneration corresponding to Cat. D, economic position D3, of the current CCNL of the Section, for activities relating to the "Photonics for health: diagnosis and multiscale therapy for cancer - PHAST "referred to in the European Project H2020-MSCA-ITN-2019," Photonics for Healthcare: multiscale cancer diagnosis and Therapy - PHAST ", Grant Agreement n. 860185, at the Department of Engineering and Architecture - Ref. Code T0121, the notice of which was published in the Official Gazette no. 69 of 31.08.2021, expiring on 30.09.2021;
considering that among the requisites necessary for participation there is, among other things, the possession of the "Doctorate in the area of Engineering or Chemical Sciences or Biological Sciences";
considering the Decree of the Director of the Department of Engineering and Architecture, received in the University protocol on 09.10.2021, prot. n. 226217, which will be brought to the ratification of the Department Council in the first useful session, concerning the request for rectification of the announcement of the public selection for the recruitment of n. 1 technologist pursuant to art. 24bis Law no. 240/2010 referred to in the Rep. Decree no. 1478/2021 prot. n. 207904 of 04.08.2021 referred to above, as among the requisites necessary for participation it was indicated "... for mere material error the PhD should have been only among the assessable qualifications";
therefore, having recognized the need, in partial modification and integration of the aforementioned procedure, to rectify the above according to the specifications reported and consequently to reopen the deadlines for the presentation of applications for participation;

ORDERS AS FOLLOWS

for the reasons cited in the introduction, which are an integral part of this device, with reference to the Decree no. 1478/2021 prot. n. 207904 of 04.08.2021 calling for the public selection for the recruitment of n. 1 technologist pursuant to art. 24bis Law no. 240/2010 with a fixed-term subordinate employment contract, with full-time hourly commitment, lasting 24 months, with remuneration corresponding to Cat.
